## EXHIBITOR'S PACKAGE

## TERMS AND CONDITIONS

1. All exhibitors are required to register for the EduVision 2009 Conference; and also pay a deposit of 50% of the cost of the exhibitor's space by September 30, 2009.
2. A deposit must be received for exhibit booth/space to be assigned.
3. Total payment for exhibit space must be made at least five working days before the start of the Conference (i.e. no later than November 16, 2009).
4. No exhibitor shall sublet the allotted exhibit booth/space. Failure to comply with this or any other term may result in termination of this contract.
5. The exhibitor (and not EduVision2009) will be liable for any loss, damage, or injury during the use, occupation, or enjoyment of the exhibit.
6. The exhibit should be set up and available for viewing by the start of the Conference on November 23, 2009.
7. The exhibit must be manned at all times during the Conference. Exhibit must be dismantled and removed by 5.00 p.m. on November 24, 2009.
